SHALL THE COMMISSIONERS BE AUTHORIZED TO EXPEND AN AMOUNT NOT TO EXCEED \$2,999,999.00 FOR THE PURCHASE OF A LADDER TRUCK AND NECESSARY EQUIPMENT TO MAKE THE EMERGENCY RESPONSE VEHICLE FUNCTIONAL, WITH FUNDING TO COMMENCE WITH THE 2023 DISTRICT BUDGET THROUGH CAPITAL APPROPRIATIONS AND/OR FINANCING OF SAME BY THE ISSUANCE OF NOTES, BONDS OR EXECUTION OF A LEASE WITH AN OPTION TO PURCHASE AGREEMENT.

#### EXPLANATORY STATEMENT

THE DISTRICT'S GROWTH AND EXPANSION OVER THE YEARS, ALONG WITH FEDERAL AND STATE MANDATED UPGRADES, HAS CREATED THE NEED FOR MORE TECHNOLOGICALLY ADVANCED EMERGENCY RESPONSE UNITS. THE PROPOSED PURCHASE SHALL MEET THE NEEDS OF THE RESIDENCES, BUSINESSES AND PROPERTY OWNERS WITHIN THE DISTRICT AND LEGISLATIVE MANDATES. THE PROPOSED LADDER TRUCK WILL REPLACE A NINETEEN (19) YEAR OLD (2004) LADDER TRUCK WHICH HAS BECOME OBSOLETE AND COST PROHIBITIVE TO REPAIR AND MAINTAIN. THE PROJECT AS PROPOSED IS ANTICIPATED TO HAVE A MINIMAL IMPACT THE TAX RATE.
