VOTE BY MAIL
NOTICE TO PERSONS WANTING MAIL-IN BALLOTS

If you are a qualified and registered voter of the State who wants to vote by mail in the Annual Election for Commissioners for the Board of Fire Commissioners of Fire District Nos. 1, 2 & 3, Township of East Brunswick and for approval or disapproval of the 2026 budget for said Districts and determine such other matters as may be required such as, but not limited to, the position(s) of Fire Commissioner(s) and approval or disapproval of capital projects(s) and funding and approval or disapproval of cancellation of capital projects, to be held on February 21, 2026, complete the application form below and send or deliver to the undersigned, or write or apply in person to the undersigned at once requesting that a mail-in ballot be forwarded to you. The request must state your home address and the address to which the ballot should be sent. The request must be dated and signed with your signature.

If any person has assisted you to complete the mail-in ballot application, the name, address and signature of the assistor must be provided on the application and you must sign and date the application for it to be valid and processed. No person shall serve as an authorized messenger for more than 3 qualified voters in an election. No person who is a candidate in the election for which the voter requests a mail-in ballot may provide any assistance in the completion of the ballot or may serve as an authorized messenger or bearer.

No mail-in ballot will be provided to any applicant who submits a request therefor by mail unless the request is received at least seven days before the election and contains the requested information. A voter may, however, request an application in person from the County Clerk up to 3:00 p.m. of the day before the election.

Voters who want to vote only by mail in all future elections in which they are eligible to vote, and who state that on their application, shall, after their initial request and without further action on their part, be provided a mail-in ballot by the County Clerk until the voter requests, in writing, that the voter no longer be sent such a ballot.

Voters also have the option of indicating on their mail-in ballot applications that they would prefer to receive mail-in ballots for this Fire Election only. Voters who exercise this option will be furnished with mail-in ballots for this Fire Election only and not future Fire Elections.

VOTING INFORMATION

1. You must be a registered voter in order to apply for a Mail-In Ballot.
2. Once you apply for a Mail-In Ballot, you will not be permitted to vote by machine at your polling place in the same election.
3. You will receive instructions with your ballot.
4. If returning your Mail-In Ballot in person it must be received by the County Board of Elections before close of polls on Election Day. If returning your Mail-In Ballot by mail, it must be postmarked no later than Election Day and received by the county board of elections no later than 144 hours (6 days) after the time for the closing of the polls of the election.
5. Do not submit more than one application for the same election.
6. You must apply for a Mail-In Ballot for each election, unless you designate otherwise under Section 1.

PLEASE NOTE

A voter may apply for a Mail-In Ballot by mail up to 7 days prior to the election. He or she may also apply in person to the County Clerk until 3 P.M. the day before the election.

Voters now have an option of automatically receiving a Mail-In Ballot for all future elections. If such voter no longer wants this option, the County Clerk's office must be notified in writing.

WARNING

This application must be received by the County Clerk not later than 7 days prior to the election, unless you apply in person or via an authorized messenger during County Clerk's office hours, but no later than 3 P.M. the day prior to the election.


